INDEMNITY AND WAIVER AGREEMENT

1. I, the undersigned

In consideration of my being allowed access to and use of the airfield situated at Tswalu Kalahari Reserve, do hereby indemnify and hold harmless and waive any and all claims I may have against:

1.1 **Tswalu Kalahari Reserve (Pty) Ltd;** and/or

1.2 The owners, managers, officers, employees, agents, independent contractors and any other person who directly or indirectly assists with the operation or management of Tswalu Kalahari Reserve (Pty) Ltd; and/or

1.3 The associated, subsidiary and/or holding companies (as defined in section 1 and Schedule 4 of the Companies Act of 1973) as well as the directors, managers, officers, employees, agents and independent contractors of the associated, subsidiary and/or holding companies of Tswalu Kalahari Reserve (Pty) Ltd,

Hereafter collectively referred to as **Tswalu,**

in respect of any loss or damage that I or any person accompanying me may suffer, including loss or damage as a result of injury or death and/or damage to or destruction of property, whether the loss or damage be direct, indirect, consequential or otherwise, arising from any cause whatsoever, including without limitation negligent or grossly negligent acts or omissions, on the part of Tswalu.

2. I hereby indemnify and hold Tswalu harmless in respect of any loss or damage that may be suffered or incurred by my dependants as a result of any loss or damage that I may suffer as contemplated in clause 1 above.

3. I undertake that all members of my family and all other persons accompanying me shall agree to and sign similar indemnity and waiver agreements and that such agreement shall be signed by parents or legal guardians on behalf of their minor children. To the extent that such agreements are not executed by members of my family and other persons accompanying me, or are not executed by parents or legal guardians on behalf of minor children, I hereby indemnify and hold Tswalu harmless against any claim by such persons as fully and as effectually as if such persons had agreed to sign such agreements.

4. I acknowledge that I am aware of and appreciate the risks and dangers, including the risk of physical injury and/or death and/or hull damage, associated with the use of, or landing on, airfields.



5. Insofar as I am, or may become, a regular user of the airfield at Tswalu, I acknowledge that this agreement will remain of full force and effect until revoked by an authorized representative of Tswalu.
6. I acknowledge that if Tswalu at its discretion arranges and pays for any emergency medical treatment for me or on my behalf, or in respect of any person accompanying me for any injury that may occur, the shall not in any way constitute an admission of liability or a waiver of rights on the part of Tswalu.
7. I am fully insured in terms of the following policies:
